

THE STRYVE BITCOIN SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The Stryve Bitcoin Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Wednesday, March 20, 2024 and ends at 11:59:59 PM ET on Thursday, June 20, 2024 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who are age 18 or older at the time of entry. Void in Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of Stryve Biltong (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

Method #1: TikTok Entry. Each Video must be unique and may not be submitted with multiple entries. During the Sweepstakes Period, participants must then enter by posting their Video to their public TikTok account using the hashtag #Stryve_Sweepstakes (the "TikTok Post"), copying the URL for the TikTok Post, visiting <https://stryvebitcoinsweepstakes.com>, completing the online entry form in its entirety including providing the URL for the TikTok Post and submitting to receive one (1) entry into the Sweepstakes (the "TikTok Entry"). NOTE: Videos may only include original music created by the entrant, to which entrant has complete rights to submit to Sponsor as required herein. Participants must not include music in a Video which they do not have rights to submit. Videos that include music may be disqualified subject to Sponsor's sole discretion that contain or are suspected to contain copyrighted music or materials.

TikTok Post must remain available and public through at least July 31, 2024 to be verified in the event the corresponding Entry is chosen as a potential winner. By submitting a TikTok Entry, entrants agree to [TikTok's Terms of Service](#). Method #2: Instagram Entry. During the Sweepstakes Period, participants must take a photo or record a video showing themselves with a package of a Stryve, Vacadillos, or Kalahari healthy protein snack product (each, a "Photo" or "Video", respectively). Each Photo/Video must be unique

and may not be submitted with multiple entries. During the Sweepstakes Period, participants must then log in to their public Instagram account, follow @Stryvebiltong on Instagram, and upload and share their Photo/ Video to their public Instagram account, including the hashtag #Stryve_Sweepstakes and @Stryvebiltong in the Video caption (the "Instagram Post") to receive one (1) entry into the Sweepstakes (the "Instagram Entry"). NOTE: Videos may only include original music created by the entrant, to which entrant has complete rights to submit to Sponsor as required herein. Participants must not include music in a Video which they do not have rights to submit. Videos that include music may be disqualified subject to Sponsor's sole discretion that contain or are suspected to contain copyrighted music or materials.

By using the hashtags, participants indicate their agreement to these Official Rules. Entrant's Instagram settings must be public. Entries uploaded from "private" Instagram accounts will not be eligible. Instagram Post must remain available and public through at least July 31, 2024 to be verified in the event the corresponding Entry is chosen as a potential winner. Entrants must follow and continue to follow @Stryvebiltong through at least July 31, 2024 in order to be notified in the event they are a potential winner. Method #3: Free, Alternate Method of Entry ("AMOE") / Mail-in Entry. To enter without purchase, participant must clearly hand-print their name, complete address, email address and phone number on a sheet of paper and mail that sheet of paper in an addressed envelope with proper postage to the following address (the "Mail-In Entry") to receive one (1) entry into the Sweepstakes: The Stryve Bitcoin Sweepstakes, PO Box 595, Social Circle, GA 30025-0595. **Each Mail-In Entry must be mailed separately and must be postmarked between Wednesday, March 20, 2024 and Thursday, June 20, 2024, and received by Thursday June 27, 2024.** Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

TikTok Entry, Instagram Entry and Mail-in Entry collectively referred to herein as "Entry" or "Entries". **Limit: One (1) Entry per person per day regardless of method of entry.** All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

For the avoidance of doubt, uploading a Video to TikTok or Instagram alone will NOT result in an entry into the Sweepstakes. Once an Entry is submitted it cannot be modified by an Entrant. Sponsor is not responsible for lost, late, incomplete, illegible, garbled, inaccurate, invalid, misdirected, undelivered, or delayed Entries. No altered or incomplete submissions will be accepted.

SWEEPSTAKES ENTRY REQUIREMENTS & CONDITIONS: All Entries must comply with the following minimum guidelines to be eligible:

- The Entrant should be the primary subject of the Photo/Video. No other individuals may appear in the Photo/Video without express written permission. If Photo/Video features a minor under the age of majority in their state of residence, you must obtain written permission from the minor's legal guardian.
- Entrant must be a registered user of TikTok to submit a TikTok Entry or a registered user of Instagram to submit an Instagram Entry and must comply with each respective company's Terms of Use/Service in order to enter the Sweepstakes.
- Posted Photo/Video must include the hashtag #Stryve_Sweepstakes in the video caption or post.
- Photo/Video must conform to the format and size requirements and limitations of TikTok or Instagram as applicable.
- Photo/Video cannot contain content that is irrelevant to the purpose of the Sweepstakes.
- Once a Photo/Video has been submitted, it cannot be modified or deleted by Entrant.
- Each submitted Photo/Video must be original.
- No duplicate Photo/Video or substantially similar Photo/Video, as determined by the Sponsor in its sole discretion, may be submitted.
- By submitting a Photo/Video taken by a third party, Entrant warrants and represents that they have secured all rights and clearances to the Photo/Video from the photographer/video recorder.
- Entry and Photo/Video cannot be profane, pornographic, sexually explicit or suggestive or contain nudity.
- Entry and Photo/Video cannot be violent or promote firearms/weapons.
- Entry and Photo/Video cannot promote alcohol, illegal drugs or tobacco.
- Entry and Photo/Video cannot defame, misrepresent or contain disparaging remarks about people, brands, products or companies.
- Entry and Photo/Video cannot contain content that defaces or depicts any person, brand, product or company in a negative or inappropriate manner.
- Entry and Photo/Video cannot be obscene or offensive, endorse any form of hate or hate group or be derogatory to any ethnic, racial, gender, religious, professional or age group.
- Entry and Photo/Video cannot reference or contain materials embodying copyrighted images, names, likenesses or other indicia identifying any brand, products, company or person, living or dead, without permission.
- Entry and Photo/Video cannot communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor, TikTok and Instagram wish to associate.
- Entry and Photo/Video cannot depict illegal activity and cannot itself be in violation of any law.
- Entry and Photo/Video cannot in any way reference persons or organizations without written permission from any person or organization whose name or likeness is used.
- Entry and Photo/Video may not include images of a known celebrity, famous or well-known person or any image which violates the right of privacy or publicity of any person.

By submitting an Entry, the entrant understands and grants to the Sponsor an irrevocable, perpetual, non-exclusive worldwide license to use their Entry, any materials, photographs or videos submitted with their Entry, name, hometown and likeness on the Sponsor's various websites and

social media sites and in advertising and/or promotional activities worldwide without compensation, permission or notification. Sponsor reserves the right in its sole and absolute discretion to alter, change or modify any Entry, which includes the Photo/Video.

By submitting an Entry, entrant warrants and represents that: (a) Entry does not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other legal or moral rights of any person or entity; (b) entrant owns all rights to the Entry, including without limitation, copyrights, and has received prior written permission from a third party if any Photo/Video was photographed/recorded by someone other than the entrant themselves; and (c) entrant will indemnify and hold harmless the Sponsor, Administrator and related entities, agents and assigns from any claims and damages (including reasonable attorneys' fees) arising from or relating to the breach or alleged breach of entrant's representations and warranties herein, the Entry, or entrant's conduct in creating the Entry.

PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Grand Prize: There are five (5) Grand Prizes available to be won. Each Grand Prize includes \$1,000 worth of a fractional share of Bitcoin. The amount and value of the fractional share of the Grand Prize is subject to market fluctuations which may change between the time winner is confirmed and the date of prize award; No difference between such amounts will be awarded. Sponsor is not responsible for any changes in value, including complete loss of value, prior to or after awarding and transfer of the Bitcoin shares to winner. Potential Grand Prize winner will be provided with an updated value of the Bitcoin at the time of winner notification. Winner will be responsible for having or setting up a digital wallet compatible with receiving the transfer of bitcoin from the Sponsor, and must confirm such account, provide any information required to enable transfer upon request, and take possession of the Grand Prize within 30 days of being confirmed. Grand Prize transfer will be initiated within five (5) business days of receipt of all required information by Sponsor. If winner fails to set up a digital wallet or provide any and all required information required to enable transfer upon request to Sponsor/Administrator within 30 days of being confirmed, winner will instead be awarded a \$1,000 check, to be sent via registered mail. Winner is responsible for any risks, costs or expenses associated with the acceptance, use, sale or holding of Grand Prize, including any taxes due in connection with winner's receipt of the Grand Prize. Selling Bitcoin may have tax consequences, for which winner will be solely responsible; winner should consult a tax advisor for any questions regarding the tax implications of the tax impact of the prize. **The ARV of the Grand Prize: \$1,000 each.**

The total ARV of all prizes available to be won: \$5,000.

There is a limit of one (1) prize per person. Odds of winning will depend upon the total number of eligible entries received.

RANDOM DRAWING: The winners will be selected in a random drawing on or about **Monday, July 1, 2024** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: Potential Grand Prize winners will be notified via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize winner to furnish their Social Security Number for the sole purpose of tax reporting, as required by law. Noncompliance will result in disqualification and an alternate winner may be selected. The prize package will be awarded within approximately 45 days after the winner is verified.

If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in their state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf, as applicable.

If a prize notification or prize is returned as undeliverable, or if winner is found to be ineligible or not in compliance with these Official Rules, that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. If Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sponsor fails to receive a sufficient number of entries to correspond to the number of prizes available to be awarded, Sponsor reserves the right to not award such prize(s).

PRIZE CONDITIONS: Prizes are not redeemable for cash, assignable, transferable and may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. Any other incidental expenses on prize not specified herein are the winner's sole responsibility.

Winner is responsible for all federal, state, local and income taxes associated with winning prize. Grand Prize winner will be required to furnish their Social Security Number for the sole purpose of preparation of tax forms as required by law.

Except where prohibited by law, entry and acceptance of prize constitute permission to use winner's name, prize won, hometown, likeness, video recordings, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.

Authorized Account Holder means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address or to whom the Instagram account is registered. Sponsor may ask any entrant or potential winner to provide Sponsor with proof, to Sponsor's satisfaction, that such party is the authorized account holder of the email address or Instagram account associated with the entry. Entry materials/data that have been tampered with or altered, or mass entries or entries generated by a script, macro or use of automated devices are void. The Released Parties are not responsible for: (i) lost, late, misdirected, damaged or illegible entries; or (ii) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof; or (iii) any injury or damage to entrant's or any other person's computer related to or resulting from participating in the Sweepstakes. By participating in the Sweepstakes, entrant (i) agrees to be bound by these official rules, including all eligibility requirements, and (ii) agrees to be bound by the decisions of Sponsor and the Sweepstakes Administrator, which are final and binding in all matters relating to the Sweepstakes. FURTHER, SPONSOR SHALL NOT BE RESPONSIBLE FOR ANY CANCELLATIONS, DELAYS, DIVERSIONS, CHANGES IN SERVICE OR ACCOMMODATIONS OR SUBSTITUTIONS, OR FOR ANY ACTS OR OMISSIONS BY ANY THIRD PARTIES BEYOND ITS REASONABLE CONTROL, INCLUDING AIR CARRIER(S) AND OTHER TRANSPORTATION COMPANIES; LODGING, RESTAURANT OR OTHER HOSPITALITY PROVIDERS; ENTERTAINMENT PROVIDERS, VENUES OR ARTISTS; OR OTHER THIRD PARTY PROVIDERS SUPPLYING ANY SERVICES OR COMPONENTS OF THE PRIZE(S) TO WINNERS AND/OR THEIR GUESTS, OR FOR ANY RESULTING INJURIES, INCLUDING MONEY DAMAGES, COSTS AND EXPENSES, PROPERTY DAMAGES, PERSONAL INJURIES OR DEATH RESULTING THEREFROM.

LEGAL WARNING: ANY ATTEMPT BY AN INDIVIDUAL, WHETHER OR NOT AN ENTRANT, TO DAMAGE, DESTROY, TAMPER OR VANDALIZE THIS WEB SITE OR INTERFERE WITH THE OPERATION OF THE SWEEPSTAKES, IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND DILIGENTLY PURSUE ALL REMEDIES AGAINST ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW.

GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Collin County, TX and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Frisco, TX. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Frisco, TX. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

PRIVACY: As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver their name, address and other information to third parties, including Sweepstakes Administrator, for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules, including, without limitation, the storing of your personal information for purposes of complying with state record retention requirements. Any information entrant provides to Sponsor may be used to communicate with entrant in relation to this Sweepstakes or on a Sweepstakes winner's list.
